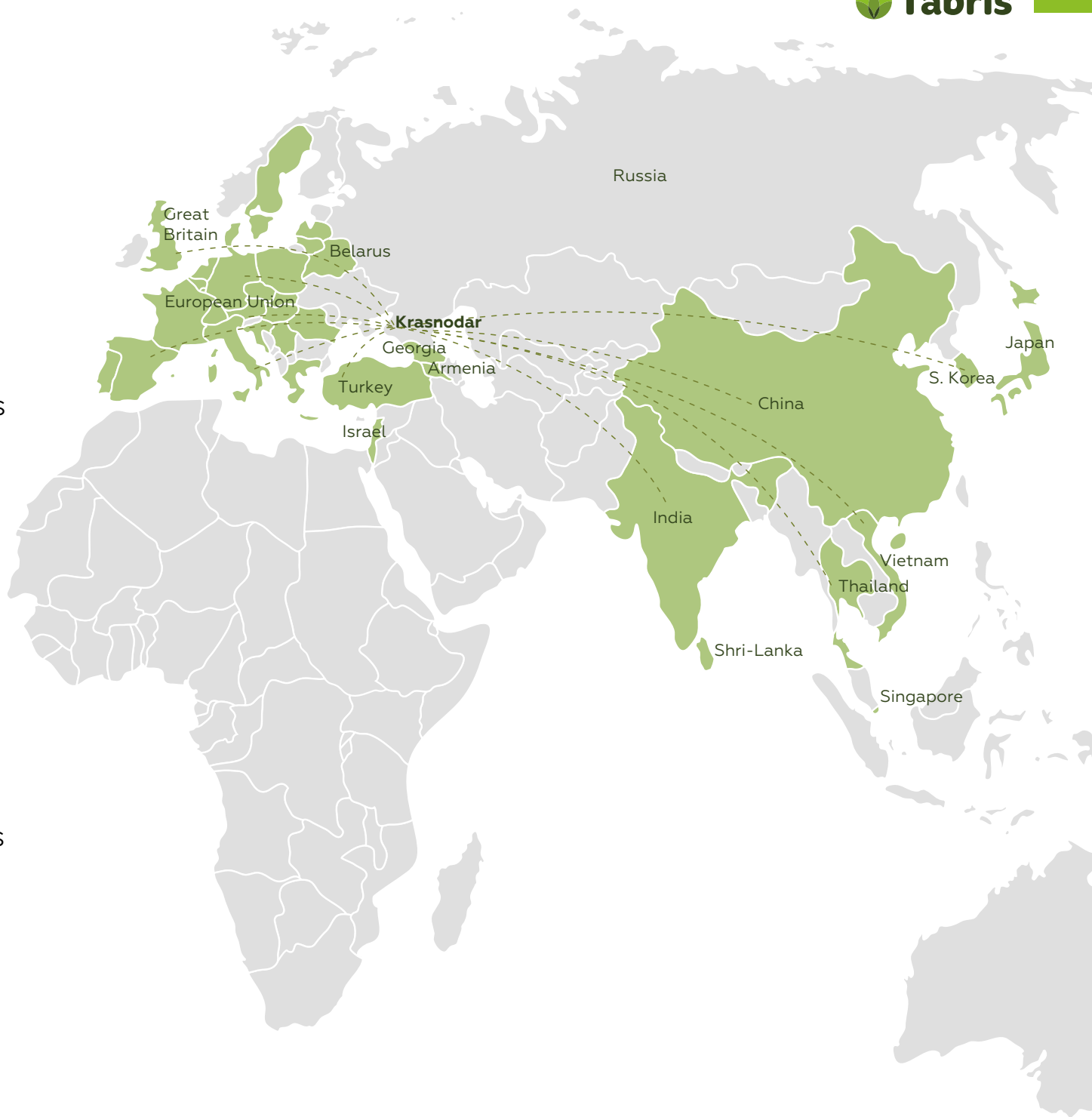
Direct import

Is it possible to export goods to Russia?

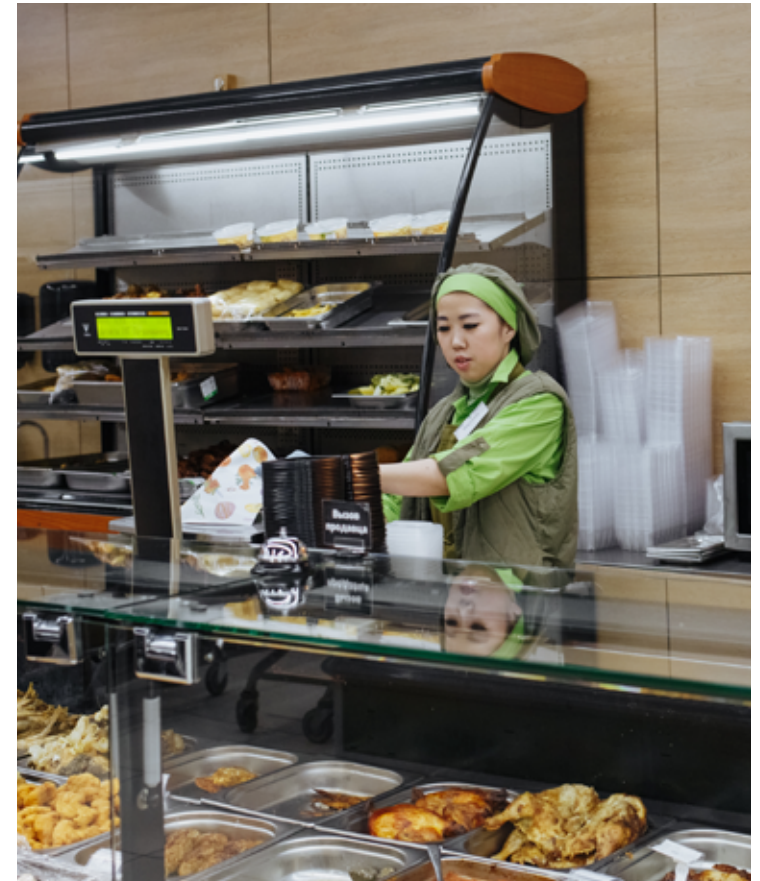
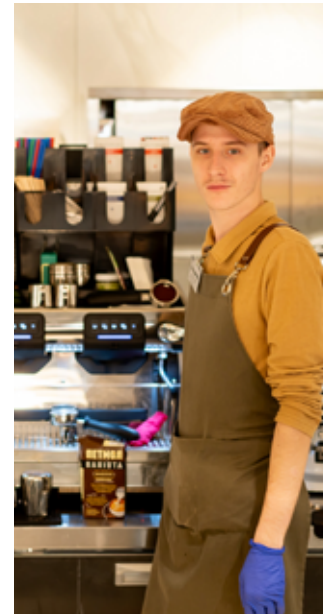
There are no prohibitions on the export of food and non-food consumer goods to Russia on the end of 2023.

Will the goods be allowed through at the borders? How is the logistics situation?

Since 2014 (when we first started importing goods and making international purchases) and until now, we deliver all goods through a large logistics company that has many partners in different countries.

This company provides all logistics procedures, including insurance of goods. The cargoes, which are contained the consumer Goods, are delivered to Russia without restrictions.
